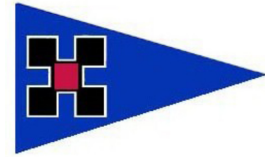

Terms of Membership

Memberships are per individual and not transferable.

Membership Categories

Senior Members are those members who have attained the age of 35.

Intermediate Members are those members who have attained the age of 23 but not yet 35.

Junior Members are those members who are not yet 23.

Annual Club Dues are required for all members. Additional fees are charged for participation in various activities: golf, tennis, and yachting. These fees are set annually by the Board of Directors. Please refer to the Castine Golf Club Annual Season Activity Registration (dues statement) for current information.

Family Memberships are available for senior and intermediate members; unmarried children under the age of 23 are extended privileges in those activities to which the family has subscribed.

Initiation fees are required of each senior and intermediate member in accordance with the schedule on the Application. The initiation fee is paid only once provided the member maintains annual membership through the payment of annual dues.

Initiation fees may be paid in installments in accordance with the schedule on the Application. Each installment is due on May 1st. Members in arrears with respect to installment payments are not members in good standing until the installment is paid. If an overdue installment is not paid within thirty days after notification of delinquency, previously made payments will be forfeited and any subsequent request for membership will require the initiation fee then current.

Members who are current with respect to the initiation fee must also pay the annual membership fees when due.

To maintain membership, members who are current with respect to the initiation fee, but do not wish to participate as members for the season, may choose to be Inactive Members, with fee as established by the Board of Directors. Failure to pay the inactive fee will be considered and acted upon as the voluntary resignation of the member.

Members who are current with respect to initiation fees and annual Club dues are considered members in good standing and enjoy all the privileges and benefits of membership in accordance with the rules established by the Board of Directors.

These terms apply only to the payment of initiation fees. They may be modified by the Board of Directors as provided for in the Club's by-laws. Additional privileges and obligations of membership are contained in the Club's by-laws and supplemental rules and regulations issues from time to time by the Board of Directors.
